

# St. Jude School 2011 - 2012 Tuition Payment Instructions

- Tuition is paid in 10 monthly payments beginning in June and running thru March
- A 5% discount is offered if all tuition is paid by 4:30 PM May 31, 2011.
- Checks are made payable to St. Jude School
- All issues concerning tuition and financial aid should be directed to the parish business manager at 598-2103.
- Please retain the tuition rates listed below for subsequent months of payment.
- Tuition payments may be returned to either the school or parish office.
- To maintain active status and therefore receive the subsidized tuition rates, families must make a regular practice of worshipping with the St. Jude Parish Community over the year (i.e. 36 Sundays throughout the year beginning June 1st. This commitment is revisited every year.)

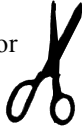

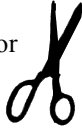
